## **Project Description**

To support young children's literacy, teachers Alison Humphrys, Carleen Pocklington and Kelsey Bagnall have incorporated Story Workshop into their classrooms.

Story Workshop is an approach supporting literacy built upon four pillars: the sharing of stories, immersion in the arts, time for play and a focus on meaning-making.

The approach started at Opal School and has since been embraced in school districts around the world. Story Workshop began with a simple question embraced by teacher-researchers: What is the connection between literacy and the arts? (Opal School, 2018)

Alison, Carleen and Kelsey have also shared this approach with other teachers in RVS by co-leading professional learning sessions. Story Workshop can also be shared with other schools and educators using social media, and through RVS' Literacy webpage.





## Capacity and Utilization

The need for additional capacity to accommodate student growth continues to be critical for RVS. The utilization rate will continue to increase from the current 86% to a critical utilization rate of 100% by 2026.

Two sites in RVS meet site readiness guidelines and are ready for construction of new schools/additions.

Item: Prince of Peace Lutheran School Next Steps

Date of Meeting: March 18, 2021

## **Background:**

Prince of Peace Lutheran School is a RVS K to Gr. 9 school offering faith-based programming. It serves families in Chestermere, Langdon, rural Rocky View County, Calgary and Airdrie. The school currently has 374 students and 36 staff. Prince of Peace Lutheran School was originally a private school which in 2006 officially became part of RVS and has been a Christian school of choice in RVS since that time.

RVS has made numerous attempts in previous years to remain in the building including requesting the Government of Alberta purchase the property and making two purchase bids ourselves. With those efforts unsuccessful, we were able to negotiate the extension of RVS' lease agreement in March of 2019.

Sage Properties presented RVS with a lease proposal during the final stages of the community consultation. The Board agreed to the lease which commenced Sept. 1, 2019 for a term of 5 years with either party being able to end the lease with 18 months notice.

In early February 2021, RVS received official notice from the landlord of the Prince of Peace Lutheran School property (Sage Properties Corp.) that it is executing its right to terminate its lease with RVS effective Aug. 5, 2022.

#### **Current Status:**

On February 12<sup>th</sup> the Board informed families and staff by way of a letter about Sage Properties lease termination notice.

The Board needs to determine a path forward. Given the option to stay in the same building under the same configuration is not possible, a school closure process must be undertaken. Board Policy 15 – School Closures was recently updated to reflect the *Education Act* and the elimination of the previously *School Closure Regulation*. Highlights from Policy 15 include:

- 3. Where the Board is considering the closure of a school, or transfer of students from one school building to another school building, the Board shall:
  - 3.1. notify in writing the parents of every student enrolled in the school that may be affected; and
  - 3.2. notify in writing any other person, municipality or community organization who may be significantly affected.

- 4. For the purpose of school closure only, the Board shall:
  - 4.1. provide adequate opportunity for the public to respond to the Board's proposal to close the school;
  - 4.2. establish a process for the Board to consider public feedback; and
  - 4.3. request of administration a report which shall be presented at a public board meeting which sets out the following:
    - 4.3.1. how the closure would affect the attendance area defined for that school;
    - 4.3.2. how the closure would affect the attendance at other schools;
    - 4.3.3. information on the Board's long-range capital plan;
    - 4.3.4. the number of students who would need to be relocated as a result of the closure;
    - 4.3.5. the need for, and extent of, busing;
    - 4.3.6. program implications for other schools and for the students when they are attending other schools;
    - 4.3.7. the educational and financial impact of closing the school, including the effect on operational costs and capital implications; and
    - 4.3.8. the educational and financial impact if the school were to remain open.

With the elimination of the School Closure Regulation, the requirement to start and finish the school closure process in the same school year has been eliminated. With this in mind, it is recommended that the Board begins a school closure process now so that options can be developed and discussed with the community in time that the Board could make a decision for implementation either for Sept. 2021 or Sept. 2022.

Timeline for the school closure consideration could be:

March 18th – Board approve motion beginning school closure process

March 18<sup>th</sup> – Letter goes out to families, staff, City of Chestermere, City of Calgary, Rocky View County, Calgary Board of Education, Calgary Catholic School Division informing them that the Board is beginning the necessary process and outline the timeline for the process and decision.

April 1st – Planning committee discusses options to be presented to public

April  $14^{th}$  – Hold online community consultation event to share information, options under consideration, provide structure for feedback to be gathered (online) - deadline for feedback Wed April  $28^{th}$ 

April 30th – Board provided with summary of feedback

May 6<sup>th</sup> – Planning committee discusses administration recommendation related to school closure

May 13<sup>th</sup> – Additional Board meeting scheduled to look at Board consideration of closure motion

May 13th – Decision communicated to relevant stakeholders

May 14th and beyond – Administration implementation of Board decision

Information Item: Rocky View Schools 2021 Zone 5 Edwin Parr Award Nomination

Date of Meeting: March 18, 2021

## **Background:**

Each year Rocky View Schools initiates a process to nominate a first-year teacher to receive the Alberta School Boards Association Edwin Parr Award.

Edwin Parr homesteaded in the Meanook area near Athabasca in 1920. Prior to 1925 he began his long career in educational affairs as a member of the George Lake School District board. He served as chair of the board with the Athabasca School Division and was on the council of the County of Athabasca from its formation in 1959 until his death in January 1963. Edwin Parr was president of the Alberta School Trustees' Association from 1956 to 1962. "Ed Parr", as he was known to all, instituted an Annual Teacher Award in his school system. Each year a member of the teaching staff was chosen to receive a gold watch and an appropriate certificate for long and meritorious service. To honour his memory and to honour the profession he so dearly respected, the Alberta School Trustee's Association (now ASBA) established the Edwin Parr Teacher Award in 1964.

### **Criteria:**

- Any first-year K-12 teacher is eligible for nomination.
- A minimum of 100 full-time equivalent days of teaching within the current school year is required (i.e. September 2020 to June 2021).
- A teacher may have up to 120 full-time equivalent days of teaching service prior to signing a full-time contract.
- A teacher must hold an Interim Professional Certificate or other valid Alberta teaching authority.
- First year teaching experience must be completed in Alberta from a school jurisdiction that is a member of the ASBA.

## The Candidate: Charnelle Fulcher

If you gravitate to spaces where the most engaged students are engrossed in authentic learning experiences you will inevitably be drawn to Charnelle Fulcher's classroom. In mere months, Charnelle has proven herself to be a flexible educator who fluidly adapts to changes. Hired in June to teach a grade 3 class in East Lake School's English stream, Charnelle was informed a week prior to the start of the year that she would instead be teaching a grade 5/6 combined French Immersion class. This was a curveball that Charnelle has hit out of the park. Ms. Fulcher sets very high expectations for her students and herself but does so in an extremely supportive way that provides students the opportunity to be the drivers in their educational journey. She provides her students with multiple means and creative ways to represent their learning and is constantly gauging their progress through effective assessment practices. She utilizes her strong collaboration and communication skills to involve parents and school community members as part of the learning process. In understanding the power of her voice and value of her ideas, Charnelle has helped advance not only her own teaching and learning practices but those of her peers through her willingness to share and collaborate. This displays an awareness and confidence that will serve her and her students throughout her career. There seems to be no doubt that Charnelle Fulcher is on the path to becoming a master teacher of Rocky View Schools.

## **Background:**

The creation of budget priorities is explicitly described within Policy 2 - Role of the Board under the Fiscal Accountability section. Specifically, item 4.1 says the Board shall "approve budget assumptions/principles and establish priorities at the outset of the annual budget process."

After reviewing the budget development process and key assumptions/principles, the Board's Budget Committee discussed budget priorities. The budget committee collected individual trustee feedback before theming the proposed priorities.

The 2020/21 Board budget priorities were:

Rocky View Schools' annual budget is driven by the goals and strategies of its Four-Year Plan to foster innovators in their learning journey, while addressing the operational needs of the jurisdiction. Recognizing that the Superintendent will demonstrate fiscal responsibility by continuing to pursue efficient and effective services, the Board of Trustees has identified the following key priorities to guide the 2020/21 budget process:

- Student success through targeted funding to classrooms;
- School based supports for students with complex needs;
- Wellness supports; and
- Literacy and numeracy skill development.

## **Current Status:**

The following 2021/22 budget priorities are recommended by the budget committee for consideration of the Board.
