Project Description

During the past two years, the learning support team at East Lake School in Chestermere has developed a framework to better identify students in need of support and deliver it through a collaborative team model. After noticing a gap in how student needs were identified, this team drew on the academic work of Jennifer Katz, Faye Brownlie and Kurtis Hewson as well as with RVS' Inclusion Practice Guide to develop a learning support delivery model that ensures students' needs are identified early in their education and teachers are empowered to get students the help they need.

This model provides teachers at East Lake School equitable access to identify the needs of students early in their education. The model relies heavily on coaching teachers through a Positive Behavior Interventions and Supports (PBIS) lens, so teachers in turn best support students based on their individual needs. Now, students that in the past may have slipped through the cracks are receiving the assistance they need, and teacher pedagogy is increasing because educators feel they can make a difference for their students. This presentation will outline the development of this service delivery framework, explain how it works and discuss future goals.

This work has been shared through the RVS divisional learning support team meetings, and East Lake School looks forward to showing other schools and divisional leaders how this delivery model works.

Item: 2023 Edwin Parr Award Nomination, Zone 5

Background:

Each year Rocky View Schools initiates a process to nominate a first-year teacher to receive the Alberta School Boards Association Edwin Parr Award.

Edwin Parr homesteaded in the Meanook area near Athabasca in 1920. Prior to 1925 he began his long career in educational affairs as a member of the George Lake School District Board. He served as Chair of the Board with the Athabasca School Division and was on the council of the County of Athabasca from its formation in 1959 until his death in January 1963. Edwin Parr was President of the Alberta School Trustees' Association from 1956 to 1962. "Ed Parr", as he was known to all, instituted an Annual Teacher Award in his school system. Each year a member of the teaching staff was chosen to receive a gold watch and an appropriate certificate for long and meritorious service. To honor his memory and to honor the profession he so dearly respected, the Alberta School Trustee's Association (now ASBA) established the Edwin Parr Teacher Award in 1964.

Criteria:

- Any first-year K-12 teacher is eligible for nomination.
- A minimum of 100 full-time equivalent days of teaching within the current school year is required (i.e., September 2022 to June 2023).
- A teacher may have up to 120 full-time equivalent days of teaching service prior to signing a full-time contract.
- A teacher must hold an Interim Professional Certificate or other valid Alberta teaching authority.
- First year teaching experience must be completed in Alberta from a school jurisdiction that is a member of the ASBA.

The Candidate: Brandy Perry

Brandy has given the school her time and talents to enhance students' educational experience and the overall culture at Beiseker Community School. Brandy has fostered a strong sense of community in our K-12 school. She has organized engaging activities to bring the elementary and high school students together for shared experiences. In just a short 5 months, Ms. Perry has created much interest in her foods program. Almost every student in Grades 7, 8 and 9 chose foods as their option for second semester, causing the school to change the timetable mid-year to accommodate the students' wishes.

Ms. Perry volunteers in many ways to support the school. She has coached two different sports teams, participated in multiple student council events, and helped with a school wide talent show. Brandy fully and seamlessly integrated into Rocky View Schools and Beiseker Community School.

Ms. Perry, along with two of her grade 11 students, presented a student showcase to Rocky View School Trustees. This presentation highlighted how hands on learning in the classroom connects with real world situations through the Entertaining with Foods instructional module. They outlined a
