Item: Purchase Orders Over \$200,000

Date of Meeting: October 8, 2020

Background:

This information item is to provide notification, in accordance with Administrative Procedure AP5201, to the Board of Trustees that purchase orders have been issued over the amount of \$200,000. Any purchase over the \$200,000 limit is to be reported to the Board of Trustees.

Current Status:

From June 1st, 2020 to August 31st, 2020 the following purchase orders were issued for an amount over \$200,000.

1. Purchase Order 098096 Issued to Blue Imp

PO 098096 was issued in the amount of \$211,662.15. This Purchase Order relates to the supply and installation of the playground at Northcott Prairie School.

- 2. Purchase Order 098199 Issued to Lynnwood Roofing-Prequalified Vendor. PO 098199 was issued in the amount of \$224,175.00. This Purchase Order relates to a large roof section replacement at Meadowbrook School. This purchase falls into the IMR fund allocation.
- 3. Purchase Order 098201 Issued to Freeze Maxwell Roofing-Prequalified Vendor. PO 098201 was issued in the amount of \$610,496.78. This Purchase Order relates to a major roof replacement at Springbank Community High School. This purchase falls into the CMR fund allocation.
- 4. Purchase Order 098209 Issued to United Roofing Inc-Prequalified Vendor.

PO 098209 was issued in the amount of \$1,321,545.75. This Purchase Order relates to a complete roof replacement, except for 4 small sections, at Bert Church High School. This purchase falls into the CMR fund allocation.

5. Purchase Order 098215 Issued to Canterbury Roofing-Prequalified Vendor.

PO 098215 was issued in the amount of \$360,077.55. This Purchase Order relates to a large roof section replacement at Springbank Middle School. This purchase falls into the IMR fund allocation.

6. Purchase Order 098239 Issued to Apple Canada. PO 098239 was issued in the amount of \$1,269,796.50. This Purchase Order relates to 900 MacBook Airs as part of Phased III evergreening.

7. Purchase Order 098254 Issued to Ainsworth Inc.

PO 098254 was issued in the amount of \$207,531.45. This Purchase Order relates to RFP Q-20-33 replacing old incandescent parking lot lighting with solar lighting at Springbank High School and Chestermere High School. This purchase falls into the IMR fund allocation.

8. Purchase Order 098300 Issued to AG Creations.

PO 098300 was issued in the amount of \$234,869.25. This Purchase Order relates to RFP Q-20-01 Education Centre Parking Lot Expansion.

9. Purchase Order 098305 Issued to Boulder Mechanical Contractors Ltd.

PO 098305 was issued in the amount of \$222,254.55. This Purchase Order relates to RFP Q-20-34 a large reno including water main replacement, valve replacements, and lighting replacements at Chestermere High School. This purchase falls into the IMR fund allocation.

10. Purchase Order 098353 Issued to Bayshore Health Calgary.

PO 098353 was issued in the amount of \$262,500.00. This Purchase Order relates to RFP Q-20-06 for specialized medical support for students and schools throughout the Division.

11. Purchase Order 098377 Freeze Maxwell Roofing-Prequalified Vendor.

PO 098377 was issued in the amount of \$338,833.95. This Purchase Order relates to a large roof section replacement at Banded Peak School. This purchase falls into the CMR fund allocation.

Background:

Annually, Rocky View Schools reviews September 30th enrolments.

Current Status:

- Total RVS enrolments for September 30, 2020 have decreased by 348 students (-1.36%) to a total of 25,289 students.
- Please see attachment for school by school enrolments, enrolments by area and preliminary utilization rate of schools.
- 3074 students are learning online.
- 629 students registered through the CLC; of which, 307 K-8 students are home schooling and 322 Gr9-12 students are in Outreach or other option via the CLC.

Item: Safe Return to Class Fund Spending Plan

Date of Meeting: October 8, 2020

Background:

On August 26, 2020 the federal government announced "up to \$2 billion in support for provinces and territories through the Safe Return to Class Fund. This will provide the complementary funding they need, as they work alongside local school boards to ensure the safety of students and staff members throughout the school year".

On September 2, 2020 the provincial government announced that the \$262.8 million coming to the province would be allocated out to public school jurisdictions, independent school authorities, early childhood services authorities with just over \$12 million held to support school authorities who are seeing a large influx in enrolment due to increased demand for their online learning programs. RVS' share in total is \$9,285,850 and will be paid out partially in Sept with the rest paid later in the school year.

Current Status:

The federal announcement stated that the funds were to be used for "supporting adapted learning spaces, improved air ventilation, increased hand sanitation and hygiene, and purchases of personal protective equipment and cleaning supplies."

Provincial website describes that "School authorities will be eligible to access this additional funding for COVID-19-related expenses, including:

- staffing
- adapting learning spaces and personal protective equipment
- cleaning and safety considerations for schools and buses
- supports for special needs students, online learning and teacher training"

Additional reporting to the province will be required by RVS to account for the money and for how it was utilized.

Senior administration met to develop a potential spending plan for these funds in line with federal and provincial requirements. These were presented to the Budget Committee on October 1, 2020 and adjusted based on the committee's discussion. The Budget Committee passed the following resolution:

The Budget Committee approve the spending plan as amended.

This \$9.3 million spend will be in addition to the \$2 million the Board already committed from reserves to increase caretaking staffing in all schools/sites and \$1.4 million of 2019/2020 operating funds dedicated towards health and safety expenditures approved in June 2020.

Highlights of the proposed spending plan of the \$9.3 million federal Safe Return to Class Fund include:

- Providing \$2 million directly to schools for the principal, in consultation with school community, to decide how best to address local issues related to COVID-19 such as sound amplification systems, reading materials and manipulatives, social-emotional learning supports, supervision, break/lunch programming staffing, class pressures
- \$2.8 million in additional teacher staffing to address class pressures now and in February, and to support online offerings
- \$2 million for additional substitute teachers resulting from COVID-19 related absences
- \$1 million for centrally funded personal protective equipment and sanitizer
- \$900 thousand to maintain bus routes that could be combined but will be maintained to reduce number of riders on the bus
- \$400 thousand for additional online curriculum resources, technical support and equipment to better support individuals working from home
- \$200 thousand for Education Centre staffing to support schools and departments with additional hiring required as a result of COVID-19 and supporting schools when there are identified COVID-19 cases
