# **Project Description**

To make the social studies curriculum more engaging for their students, Sarah Thompson School Teachers Getta Behal, Kristie Mackie and Sarah McLeod have introduced gamification to create Survive and Thrive. The central idea of the game revolves around two statements:

- Grade 2 Diversity enriches communities through relationships, perspectives, change, and citizenship.
- Grade 3 Diversity enriches global communities through relationships, perspective, change, and citizenship.

Survive and Thrive begins with a story describing a setting and situation for the students. As students play, they are given "situations" (small problems they must solve that drive the game forward) and "encounters" (larger problems that are directly connected to the curriculum and have students inquire into concepts to make decisions and/or find solutions). The game encourages students to build and use 21st century competencies.

Survive and Thrive engages students through roleplaying, where their creativity and agency drives the direction of the learning. In this approach, teachers apply multiple disciplines to deliver key concepts of the curriculum. The concepts that are taught allow students to transfer their knowledge through the gaming experience. These authentic experiences allow students to apply their learning to real-life situations. Further, the game is highly engaging, fun, and allows for multiple entry points for all students.

## Background:

Alberta Education provided the following direction, regarding CMR Projects, on Aug. 5, 2021:

In preparation for Budget 2022, Education has been asked to identify Capital Maintenance and Renewal projects that are priorities for schools over the upcoming budget year.

This is intended to allow for greater transparency and accountability for government decisionmakers regarding the effectiveness of Capital Maintenance and Renewal investments.

For Education, we are requesting that these projects be aligned with the Infrastructure Maintenance and Renewal criteria outlined in the School Capital Manual (2015). In general, the work can include projects that:

- address building components that have failed or are near failure;
- repair or replace (including life cycle replacement) an existing capital component or asset;
- address code repairs;
- address hazardous materials abatement issues;
- *improve barrier-free access or indoor air quality; and*
- improve energy efficiency, program functionality or operating efficiency.

Additional criteria are outlined in the attached CMR Guidance Document.

Please complete all fields in the attached template, listing your projects in the order of importance to your school jurisdiction. In addition to new projects that you plan to undertake starting in April 2022, please also include any projects submitted last year that are currently underway and will not be completed until the 2022-2023 GOA fiscal year (April 2022 to March 2023). If there are projects that you submitted last year that are not currently underway but remain a priority, please include them in this year's submission.

For projects to be considered for inclusion in Education's Capital Maintenance and Renewal request, all completed forms should be submitted to <u>EDC.CPData@gov.ab.ca</u> by **September 1**, **2021**.

Should funding be approved, additional guidelines regarding funding and reporting requirements will be provided.

## **Current Status:**

As the submission deadline was Sept. 1, 2021, the Operations branch prepared and submitted a list of prioritized projects. The list is shown in Appendix A.

Item: Preliminary Enrolment Update

# Background:

Annually, Boards across Alberta submit to the Government of Alberta their student enrolment as of September 30. While enrolments fluctuate daily, these September 30<sup>th</sup> numbers are important for funding purposes and generally used to describe a school division's student population.

At the end of September 2020 RVS had 25,289 students that we served. This is a headcount and is not the full-time equivalent (FTE) which would be lower as Kindergarten students only count as 0.5FTE.

Due to the pandemic, for the first time in recent memory, RVS' enrolment declined from the previous year (25,637 in September 2019).

# **Current Status:**

In January 2021, RVS submitted to government our projected enrolment for the 2021/22 school year. Projecting a division's enrolment is a complicated art which looks at community growth, grade to grade growth, historical trends, and for the first time ever in RVS, we utilized a specific piece of software that uses census and birth rate data. The projection for the 2021/22 school was 26,495 students. This would be an increase of 1,206 students from last year (4.7% growth compared to fall 2020). Driving the growth is the return of a number of grades 1's who would be attending school for the first time after not attending Kindergarten due to the pandemic. Other growth is a result of general community population growth.

Enrolments fluctuate almost daily with students entering and exiting RVS. As of Thursday September 16, 2021, the following describes our current enrolment:

It is critical to know that the 2021/22 enrolment numbers will continue to fluctuate, and these are ONLY preliminary numbers. Final enrolments will be determined as of September  $30^{\text{th}}$ .

If we remain at 26,700 students, then our growth compared to 2020 will be 5.5%.

# Future Direction:

Enrolments will be finalized for the purpose of Alberta Education reporting on September 30, 2021, and shortly thereafter administration will report to the Board the overall numbers, grade breakdowns, school breakdowns and comparisons vs projections and utilization rates as of September 30<sup>th</sup>.
