11. Adjournment

(4) Notwithstanding subsection (1), when the number of trustees at a meeting is less than a quorum because one or more trustees have declared a conflict of interest with respect to a matter before the board at the meeting, the Minister may order that the remaining trustees are deemed to be a quorum for the purpose of deciding that matter.

Voting on questions

8(1) All resolutions must be submitted to a board by the chair of the board or a trustee, and no seconder is required.

(2) The chair of the board and every trustee present at a meeting of the board must vote for or against every question unless

- (a) in a specific case, the chair or a trustee is excused by resolution of the board from voting, or
- (b) the chair of the board or a trustee has a pecuniary interest in the matter and abstains from voting as required by section 88(1) of the Act.

(3) The secretary of the board must, whenever a recorded vote is requested by a trustee, record in the minutes the name of each trustee present and whether the trustee voted for or against the matter.

(4) Notwithstanding subsection (3), the secretary of the board must, immediately after a vote is taken and on the request of a trustee, record in the minutes the name of that trustee and whether that trustee voted for or against the matter or abstained.

Required votes

9 At a meeting of a board the following applies:

- (a) each question must be decided by a majority of the votes of the trustees present;
- (b) in case of an equality of votes, the question must be decided in the negative;
- (c) a vote on a question must be taken by open vote;
- (d) notwithstanding clause (c), with respect to the election of a chair of the board or a vice-chair of the board, if one or more trustees request that the vote be by secret ballot, the vote must be by secret ballot.

Background:

Current Status:

Item: 2022 Modular Classroom Planning

Date of Meeting: October 28, 2021

Background:

- The term *modular unit* is used to describe a moveable classroom built at a central location and transported to schools across Alberta. Modular units have long been used as added space for overcrowding schools and are a cost-effective way to allow for the expansion and contraction of a school building as student population fluctuates.
- Provincial funding, through Alberta Education's Annual Modular Classroom Program, is provided for the addition of new or the relocation of existing modular units to ease enrolment pressures in communities where school jurisdictions are experiencing high student enrolment growth. Funding may also be provided for the replacement of existing portable classrooms due to demonstrated health and safety issues.
- Modular units can be attached directly to a core school by using a "connecting link" or remain as freestanding units (i.e., not attached to the main school structure). A connecting link is the connecting corridor used when attaching modular units to the permanent building.
- With the additional 12 units approved in the Spring, RVS will have 385 modular classrooms on our schools. See Attachment A.
- Annually, Alberta Education requires school districts across the province to review their accommodation needs to determine the demand for additional modular units. As of November 1, 2021, the submission for modular units is to be submitted to Alberta Education for their consideration.

Current Status:

- September 30, 2021, enrolments have been received and reviewed. During the review it has become apparent RVS continues to experience areas of growth needing to be addressed in a timely manner.
- The schools, identified by priority on Table 1, require the addition of modular units for the 2022-23 school year. Prioritization and number of units being requested is based on expected accommodation changes, projected enrolments, and utilization numbers. The projected utilization rates, identified below by year, do not consider the additional capacity that is being requested through the addition of modular units (if approved).

Current Status:

The purpose of the committee is to provide guidance and support to the Board and the Division as RVS works to create an environment where all students and staff are knowledgeable, understanding, and respectful of the rich diversity of Indigenous cultures while honouring Indigenous history, cultures, languages, and perspectives.

The committee will focus on:

Terms of Reference

Purpose:

To provide guidance and support to the Board and the Division as RVS works to create an environment where all students and staff are knowledgeable, understanding and respectful of the rich diversity of Indigenous cultures while honouring Indigenous history, cultures, languages and perspectives.

Membership:

- a) Two Trustees, one of which must be the Board Chair or Vice-chair
- b) Stoney Nakoda First Nation representative
- c) Tsuut'ina First Nation representative
- d) Elder commonly working with RVS
- e) Métis Nation of Alberta Region 3 representative
- f) Superintendent of Schools
- g) Associate Superintendent of Learning
- h) ATA Local #35 representative
- i) RVS' Indigenous Inclusion Council Chair
- j) Three RVS high school students (two of which must be Indigenous students)

The committee chair will alternate between a Trustee and an Indigenous representative for each meeting.

Authority:

- a) Make recommendations for the Board's consideration related to:
 - a. advancing Indigenous student success
 - b. reconciliation efforts
 - c. creating an environment where all students learn about Indigenous ways of being and knowing
- b) Make recommendations for the Superintendent's considerations related to:
 - a. professional learning for staff
 - b. programs for students
 - c. protocol matters
- c) Request relevant information from the Superintendent
