EXEMPLARY PRACTICE: RVS COMMUNITY LEARNING CENTRE – DUAL CREDIT EXPERIENCES

Project Description

Rocky View Schools (RVS) has offered dual credit opportunities to students for approximately 10 years. High school students engage in career-based programs and earn credits that count toward both their high school and post-secondary educations. Dual credit programming also allows students to have real-world, hands-on learning experiences, which is one of the outcomes of RVS' Four-Year Plan.

In this presentation, students from the RVS Community Learning Centre will share their experiences with two dual credit offerings. This year marks the first time RVS has partnered with Olds College for its Vet Technician Assistant (VTA) program. Grade 12 student Ava Diebolt will discuss her participation in this program, which will culminate with her receiving a diploma in VTA to become a fully certified vet tech.

For two years, RVS has partnered with Olds College to offer welding courses. This year, RVS is transporting two cohorts of 15 students to Olds for this program. Grade 10 students Tiana Jacklin and Dustin Loots will share their experience, which allows them to earn credits towards an agricultural heavy equipment certificate.

SCHOOL ON POWELL STREET STUDENT ACCOMMODATION #1175-2023 MOTION BY TRUSTEE FIONA GILBERT:

- Relocate Cochrane Christian Academy into the school building located at 129 Powell Street in Cochrane starting September 2023.
- Name the school facility Cochrane Christian Academy starting August 2023.
- Establish a French Immersion middle school program at Mitford School starting with Grade 5 for the 2023-24 school year and growing by an additional grade for each subsequent year until it reaches Grade 8.
- Adjust the French Immersion attendance boundary in Cochrane so that students living in Heartland and all communities south of the train tracks are designated to attend Mitford School for French Immersion as follows:
 - As of the 2023-24 school year, Grade 5 Fl students living in Heartland and all communities south of the train tracks are directed to attend Mitford School.
 - As of the 2024-25 school year, Grade 5-6 FI students living in Heartland and all communities south of the train tracks are directed to attend Mitford School.
 - As of the 2025-26 school year, Grade 5-7 Fl students living in Heartland and all communities south of the train tracks are directed to attend Mitford School.
 - As of the 2026-27 school year, Grade 5-8 FI students living in Heartland and all communities south of the train tracks are directed to attend Mitford School.

The Rocky View Schools (RVS) Board of Trustees (the Board) invited area MLA candidates to an information meeting which was held earlier this week here at the Ed Centre on April 25, from 7-8pm.

As locally elected trustees, we share a passion for community and a desire to contribute to a brighter future. We believe open dialogue and information sharing are key to our ability to deliver on this commitment. It is in this spirit the Board invited all provincial election candidates within the communities we serve to meet so we can share how RVS enhances the education experience for 27,950 students. Construction is progressing on a new school in Langdon, which is set to open in September 2024. The school has been planned as a junior/senior high school, and will likely change the future attendance boundaries for Chestermere High School and grade configurations of Sarah Thompson School, Langdon School and Indus School.

RVS is launching a public consultation and online engagement that will help in formally deciding the grade configuration and attendance area for the new school. The Board will be participating with a public meeting on May 2 in Langdon at Langdon School to gather input, and feedback can also be provided through RVSEngage.com beginning the same day. All feedback must be received by May 25. The Board of Trustees will use this information to help determine an accommodation plan for the new school and a decision is anticipated on June 15.
