## **EXEMPLARY PRACTICE: LEARNING SUPPORTS – STUDENT AQUATICS**

This year, Learning Supports has launched inclusive student aquatics programming that takes place each Tuesday at Genesis Place in Airdrie. During this time, students in Grades 1-12 are supported by learning assistants, a physiotherapist, occupational therapist and speech language pathologist so they can take part in activities that support goals identified in their Student Success Plans (SSP). Student aquatics promotes social and functional communication, motor skills, personal growth, independence and community living.

While participating in the aquatic activities, students are learning water safety and strengthening their motor function and skills. By visiting a public community setting, they are gaining confidence, independence and experience at the pool, on the bus and transitioning between the two locations. They are also growing their connections with peers and adults by using their social and functional communication skills.

Student aquatics provides an inclusive learning environment in Airdrie, which is one of the desired outcomes of RVS' Education Plan. Learning Supports is eager to grow student aquatics to other communities in RVS and is seeking out partnerships in Cochrane and Chestermere.

On April 8, the Board was informed by the Minister of Education of proposed amendments to the Education Act through Bill 51. Rocky View Schools is reviewing the proposed amendments to understand the potential impact if passed and is awaiting further information and clarity from the government.

On April 15, the Board received official notice from Ministers of Infrastructure and Education of school project approvals (Planning Funding) for new Gr. 10-12 school in West Chestermere (Chelsea), and new K-9 school in SE Airdrie (Lanark) awarded as part of Budget 2025.

Also on April 15, the Board received approval from the Minister of Education to use Infrastructure Maintenance and Renewal dollars towards the cost of constructing a connector link for the 2 modular classrooms added to Cochrane High School.
